

**JOINT STATEMENT OF THE COMMITTEES RESPONSIBLE FOR
ARTIFICIAL INTELLIGENCE OF
THE PARLIAMENTS OF THE VISEGRÁD COUNTRIES**

on Artificial intelligence as a tool for economic development

(Budapest, 27 November 2025)

We, the responsible committees of the Visegrád countries' parliamentary chambers

- (1) recognise that artificial intelligence (AI) is a key factor in the sustainable growth, innovation capacity, and competitiveness of the Central European region, which as a strategic economic development tool, can create new jobs, ensuring more efficient government operations, and increasing business productivity;
- (2) are aware that the technological revolution is ushering in a new era in the economy, industry, education, and public administration. Our goal is for the Visegrád countries to become active shapers of this change and early adopters, not just followers;
- (3) are ready to cooperate in developing a coordinated artificial intelligence strategy that promotes connection between research, industry, and the public sector, with a particular focus on creating shared data and innovation platforms;
- (4) support the digitisation and AI integration of small and medium-sized enterprises, for example through regional innovation programs, mentor networks, and experimental (sandbox) environments;
- (5) pay special attention to ethical, transparent, and secure AI developments, as well as developing human resources through joint education and training initiatives so that future generations are prepared to enter the AI-based economy;
- (6) point out that the development and application of artificial intelligence are closely linked to the preservation of linguistic diversity. To preserve our cultural heritage and ensure the digital presence of the small Central European languages, we jointly strive to ensure that AI systems and their databases fully support the languages of the Visegrád countries;
- (7) promote better coordination, so that the interests and experiences of the Visegrád countries are presented in a more unified manner in the shaping of artificial intelligence policies in the European Union. Emphasize that EU funding for the development of artificial intelligence needs to be significantly increased to boost our competitiveness.
- (8) support knowledge transfer and cooperation between our parliaments in the use of AI systems, with particular attention to sharing best practices;

- (9) urge the artificial intelligence councils of the Visegrád countries to work together, consult regularly, and identify potential areas of cooperation;
- (10) promote the strengthening of the position of the Visegrád countries in the field of artificial intelligence as part of our joint approach to improving computing capacities, enhancing resilience within energy infrastructure, and developing common projects for data centres, including the shared use of supercomputer computing power, while at the same time supporting cross-border cooperation in this area that mutually benefits our national minorities;
- (11) underline the importance of cooperation between Visegrád countries in achieving technological development that benefits all citizens and contributes to strengthening digital sovereignty, economic resilience, and social well-being.
